## 1 Introduction

This Accessibility Plan has been drawn up in compliance with current legislation and requirements as specified in Schedule 10, relating to Disability, of the Equality Act 2010. School Governors are accountable for ensuring implementation, review and reporting on the progress of the Accessibility Plan over a prescribed period. Worplesdon Primary School is committed to providing an accessible environment which values and includes all pupils, staff, parents and visitors regardless of their education, physical, sensory, social, spiritual; emotional and cultural needs. We are committed to challenging negative attitudes about disability and accessibility and to developing a culture of awareness, tolerance and inclusion.

## 2 Definition of Disability

Equality act (2010) states that ‘A person has a disability if he or she has a physical or mental impairment that has a substantial and long-term adverse effect on his or her ability to carry out normal day-to-day activities.’

The definition of Special Educational Needs (SEND Code of Practice September 2014) - A child or young person has special educational needs if he or she has a learning difficulty or disability which calls for special educational provision to be made for him or her. A child or young person has a learning difficulty or disability if he or she:

- 1 has a significantly greater difficulty in learning than the majority of others of the same age, or
- 2 has a disability which prevents or hinders him or her from making use of facilities of the kind generally provided for others of the same age in mainstream schools. This will include students with medical needs.

## 3 Key Aims

To ensure for all pupils with a disability that they have:

- Total access to our setting’s environment, curriculum and information and
- Full participation in the school community.

## 4 Principles

Compliance with the Equality Act is consistent with our setting’s aims and equal opportunities policy and SEN information report.

- Our staff recognise their duty under the Equality Act:
  - Not to discriminate against disabled pupils in their admissions and exclusions, and provision of education and associated services
  - Not to treat disabled pupils less favourably
  - To take reasonable steps to avoid putting disabled pupils at a substantial disadvantage
  - To publish an accessibility plan
- In performing their duties governors have regard to the Equality Act 2010
- Our setting
  - recognises and values the young person’s knowledge/parents’ knowledge of their child’s disability
  - recognises the effect their disability has on his/her ability to carry out activities,
  - respects the parents’ and child’s right to confidentiality
- The setting provides all pupils with a broad and balanced curriculum that is differentiated, personalised and age appropriate.

## 5 Financial Planning and Control

The Head Teacher, SLT and the finance committee will review the financial implications of the accessibility plan as part of the normal budget review process.

## 6 Increasing Access for Disabled Pupils to the School Curriculum

This includes teaching and learning and the wider curriculum of the school such as participation in after school clubs, leisure and cultural activities or school visits.

The school ensures that disabled members of the school community are seen in a positive light through displays and assemblies promoting disability and providing positive role models of adults with disabilities to encourage success and achievement.	All school staff	

## 7 Improving Access to the Physical Environment of the School

This includes improvements to the physical environment of the school and physical aids to access education.

Action to Ensure Outcome	Who is Responsible	Review
<p>The school takes account the needs of pupils with physical difficulties and sensory impairments when planning and undertaking future improvements and refurbishments of the site and premises, such as improved access, lighting and colour schemes, clear signage and more accessible facilities and fittings.</p> <p>The school environment already incorporates many features to ensure accessibility to students with disabilities. These include:</p> <ul style="list-style-type: none"> <li>● A lift giving access to the first floor in the Aviary.</li> <li>● Ramp leading into the school entrance.</li> <li>● Ramps instead of steps leading up to the outside classroom doors for Magpies and Sparrows classes in year 3.</li> <li>● Disabled toilet in the aviary.</li> <li>● Single level flooring leading up to the Performing Arts Centre.</li> <li>● Blinds in classrooms.</li> <li>● A ramp has been created next to the steps by the outside gym equipment to give access to the KS1 playground, field and forest schools area for children and adults with reduced mobility.</li> </ul>	<p>Head Teacher, Deputy Head, Caretaker, Business Manager, SENDCO, Governors, SLT</p>	
<p>School staff create personalised risk assessments and access plans for individual pupils.</p>	<p>Class teachers/ SENDCO/ SLT</p>	
<p>The school liaises with outside agencies to ensure hearing and visual environment in classrooms are regularly monitored to support hearing impaired and visually impaired children.</p>	<p>LA HI and VI advisory teachers in conjunction with SENDCO</p>	
<p>The school ensures that actions, including emergency evacuation procedures, are clear and that staff are capable of carrying them out.</p>	<p>Head Teacher, Deputy Head Teacher and SLT</p>	

## 8 Improving the Delivery of Written Information to Disabled Pupils

This will include planning to make written information that is normally provided by the school to its pupils available to disabled pupils. Examples might include handouts, timetables, textbooks and information about school events. The information should take account of pupils’ disabilities and pupils’ and parents preferred formats and be made available within a reasonable time frame.

Alternative provision, including IT equipment, writing slopes, specialised writing equipment, enlarged fonts, is given to pupils to enable them to engage in all learning experiences within the school environment. This includes access to chromebooks and laptops when required e.g. for extended writing tasks.	Class teachers with support from the SENDCO	
The school creates and offers information in alternative formats. Access arrangements are considered and put into place for statutory testing.	Assessment co-ordinator/ SENDCO and class teachers	
The school adopts a proactive approach to identifying the access requirements of parents and makes reasonable adjustments where possible.	All school staff
